Course providers wishing to create prelicensing courses to be approved by the Board must create courses that match the title and content of the modules shown in the *Real Property Appraiser Qualification Criteria* as set forth by The Appraisal Qualifications Board of the Appraisal Foundation. Course sponsors who do not wish to create their own course material may apply to the Board using materials from a course provider that have been approved by the AQB Course Approval Program and the Board as suitable for qualifying education. **The following is what must be submitted for approval: this form completed in its entirety, permission of the course owner to seek approval, a Secondary Provider Agreement and School's Student Enrollment Contract.** In addition, if this is the first time your school has been considered for Board Qualifying classes, we will need the School Director form completed. Applicants are referred to Board Rule 57B which is posted on our website at www.ncappraisalboard.org.

Instructor Requirements: You are required to use a Board approved instructor for all core curriculum courses. If you are using an instructor who is not currently approved by the Board then he or she must submit an Instructor Application that must be approved by the Board at a scheduled meeting prior to the instructor teaching.
